23917	Core	Lytec will no longer generate an error when attempting to run Accounts Receivable reports with large amount of data output. Previously, it could generate an error and close Lytec.
		Steps to recreate

		2. On the Admin menu, select Preferences. The Preferences screen appears.
		3. Select the Reports tab.
		4. Ensure that A/R Totals Aging Report is selected.
		5. On the Reports menu, point to Aging Reports, and select A/R Totals Aging. The Print AR Totals screen appears.
		6. Leave the default settings and click the <b>Preview</b> button.
		7. Verify that the report previews to the screen and there are no errors.
